Program Times:

Program Costs for school year 2019-2020:

- Weekly rate for 5 days is \$120.00
- The private rate for 4 days is: \$105.00 per week
- The private rate for three days is: \$85.00 per week
- The private rate for two days is: \$65.00 per week
- **February and April vacation weeks** Tuesday-Friday, total cost of \$210.00, program hours 8:00-6:00.

Enrollment Process

We are currently accepting registration forms with enrollment packets for both the Franklin Street location (4th-6th) and the Webster Avenue location (K-3rd) for the 2019-2020 school year. PLEASE NOTE, priority is given to families that request full time (M-F).

If your child has a chronic medical condition which requires medication or may require medication (such as an epi-pen) while at the program, a Medication Consent Form and Individual Health Care Plan will need to be completed. The medication will need to be provided to the program in its original box.

Y@PHA programs are licensed by Department of Early Education and Care

- Educators (including Site Director and front line group leaders) are versed in EEC regulations and adhere to policies and procedures to ensure compliance.
- Educators are vetted through detailed screening process, which includes an application and comprehensive interview process followed by reference checks.
- All educators have a CORI Background Record Check and FBI fingerprinting.
- Directors and group leaders engage in 20 hours plus per year of professional development, including 1/3 devoted to working with diverse learners.
- Our educators are trained in CPR/AED and First Aid.
